I am directed to say that the Governor of Assam is pleased to accord Revalidation of Administrative Approval for an amount of Rs.464.20 Lakh (Rupees Four Crore Sixty Four Lakh Twenty Thousand) only and Financial Sanction of Rs.26.88 Lakh (Rupees Twenty Six Lakh and Eighty Eight Thousand) only as Part payment of 2nd installment of Central Share for implementation of the project "Construction of Recreational Centre at Lakhipur (Cachar) under 10% Central Pool Fund for the year 2017-18. with the following terms and conditions:

1. Any increase in the project cost shall not be considered by the Government.
2. The Utilization Certificate and Progress Report should be submitted in time for subsequent release of fund by the Government of India and the State Government.
3. The Director, Town & Country Planning, Assam will inspect the said project with regard to the use of Standard Quality products in constructing the work.

The expenditure is subject to observance of all financial rules, procedures and formalities and observance of the provision of the AFRBM Act, 2005.

The Central Share expenditure is debit to the Head of Account "2217 - Urban Development - 03 - Integrated Development of Small & Medium Towns -800-Other Expenditure-3036-10% Central Pool Fund for NE Region -000-35-Grants for creation of capital Assets-99-others, CSS, Grant No.31, Urban Development, Town & Country Planning, General (Page VI 259) for the year 2017-18.
