With reference to the above, I am directed to say that the Governor of Assam is pleased to accord "In Principle" Approval for an amount of Rs.135.50 Crore (Rupees One Hundred Thirty Five Crore and Fifty Lakh) only for the following Nineteen Schemes approved by Finance (EC-III) Department for the scheme- City Infra Development Fund (CIDF) for Nagaon Town as per the proposal submitted by you vide letter mentioned under reference No. 1 during the year 2017-18.

It may be mentioned that the total project cost of the scheme- City Infra Development Fund (CIDF) for Nagaon is Rs.200.00 Crore and out of this an amount of Rs. 4.00 Crore is for preparatory works and mainly towards the cost of Detailed Project Report preparation and other contingency cost.

The expenditure is subject to observance of all financial rules, procedures and formalities and observance of the provision of the AFRBM Act,2005.

The expenditure is debitable to the Head of Account "2217 - Urban Development - 05- Other Urban Development Schemes - 192 - Assistance to Municipalities/Town Committees - 5902- City Amenities Development Fund - 000 - No Sub Sub Head - 35 - Grants for creation of Capital Assets - 99 - others. TG- UL. (page - VI - 281). Grant No. 34 - Urban Development- Municipal Administration for the year 2017-18.

Further, you are requested to submit a fresh proposal against the Schemes not concurred by the Finance (EC-III) Department equal to the amount against the Schemes submitted vide letter mentioned under reference No. 1. The Department will accord Financial Sanction of Rs.4.00 Crore for the preparatory works and will move Finance (Budget) Department for release of Rs.2.00 Crore out of Rs.4.00 Crore at present which may be drawn by you and deposit in any existing Savings Bank Account being operated at the District Level for any other Town Development or the account that is being currently audited by Accountant General, Assam.


You are also requested to forward the drawing/designs/DPRs prepared with the help of competent technical officers alongwith the Bid/RFP documents to the Director, Town & Country Planning, Assam, and float the tenders after receipt of the Administrative approval and Technical Sanction and follow due process to elicit proposals from the prospective bidders and finalise the same and submit your recommendation to the Director, Town & Country Planning, Assam. The Director, Town & Country Planning, Assam will examine the same and submit the proposal to this Department with their observation and this Department will issue the Financial Sanction for the approved projects. On receipt of the same, you will award the work to the successful bidders and will raise the bills including mobilization advance/running bills through the Director, Town & Country Planning, Assam to this Department and the amount will be regulated through FOCs.

The City Level CIDF Implementation & Monitoring Committee (CCIMC) constituted for this purpose is responsible for recommendation of the project, execution and monitoring of the works. As Deputy Commissioner, Nagaon, you are authorised to draw and disburse the amount under CIDF budgeted under Grant No.34.

The guidelines of City Infra Development Fund (CIDF) formulated vide this Dept's Notification No. UDD(T)66/2017/4 dated 6th May,2017 is to be strictly followed while implementing the said scheme.


