Sir,

I am directed to convey that the Governor of Assam is pleased to accord Financial Sanction for an amount of Rs.455.00 Lakh (Rupees Four Crore Fifty Five Lakh) only as 1st installment of State Share (40% of eligible State Share for SC Beneficiaries) for implementation of Pradhan Mantri Awas Yojana (PMAY) -Housing for All (U) in 7 (seven) towns during 2017-18.

The Ministry of Housing and Urban Affairs, Govt. of India has accorded approval for Central assistance amounting to Rs.36510.00 Lakh for the 8 (eight) BLC projects at a total project cost of Rs.72825.27 Lakh for the State of Assam for implementation of the PMAY-Housing for All (U) during 2016-17 and accordingly released an amount of Rs. 1365.00 Lakhs as first installment of Central Share (40% of CA) for Scheduled Caste Beneficiaries for 7 (seven) towns excluding Guwahati City.
