Dated Dispur, the 5th October, 2023

No. E-263477/272: On the recommendation of the Assam Public Service Commission vide No. 45PSC/CON/Exam-15/2022-23 dated 25.08.2023 and in the interest of Public Service, the Governor of Assam is pleased to appoint the following Graduate Engineers, temporarily and until further orders as Assistant Engineers (Civil) in the Directorate of Municipal Administration, Assam under the Department of Housing and Urban Affairs in the pay scale of Rs. 30,000/- to Rs. 1,10,000/- (PB-4) with Grade Pay of Rs. 12,700/- p.m plus other allowances as admissible as per Rules and to post them in vacant posts as shown against their names.

The appointments are purely temporary and may be terminated at any time without notice and without assigning any reason thereof. The services of the appointees are liable to be transferred to anywhere in Assam.

The appointees joining in State Government Services on or after 01/02/2005 shall not be governed by the existing Assam Services (Pension) Rules, 1969 and orders issued thereunder from time to time. Their pension and other retirement benefits will be governed by the "New Defined Contribution Pension Scheme".

Each appointee should join within 15 (fifteen) days from the date of receipt of this notification.

No T.A/D.A is admissible to the appointees either on joining in the posts or on termination of appointment.

Their cadre-wise Inter-se-seniority will be fixed later on as per merit list recommended by APSC.
