It is mandatory that a single, joint inspection shall be carried out for the construction permit approval in urban areas and industrial development corporations by the officials from the respective authorities as applicable on case to case basis:

- i) Municipality
- ii) Development Authority
- iii) Gaon Panchayat
- iv) Fire & Emergency services
- v) Assam Water Supply and Sewerage Board
- vi) Assam Power Distribution Company Limited
- vii) Department of Labour
- viii) Archeology Department
- ix) NHAI
- x) State Pollution Control Board
- xi) Airport Authority of India
- xii)Site Engineer of Municipal Board/Corporation or responsible official of Gaon Panchayat

Inspections shall be scheduled on every Tuesday and Wednesday of the week. The list of sites to be inspected, indicating location and time shall be intimated to the concerned inspecting authorities as well as the building owner by the Site Engineer of Municipal Board/Corporation or responsible official of Gaon Panchayat of the concerned area.

Site Engineer of Municipal Board/Corporation or responsible official of Gaon Panchayat of the concerned area shall be the Nodal Officer for the purpose and will coordinate with the concerned agencies.

This will apply to all areas within the jurisdiction of Municipal Corporations, Municipal Boards, Development Authorities area as well as Industrial Development Corporations.

This will come into force with immediate effect.
