- Submission of utilization certificate and audited statement of expenditure to be submitted in due course(for GIA)
- All other general conditions of financial propriety
- Works must be completed within the stipulated time of Administrative Approval. No further escalation of the estimate cost will be allowed.
- Physical Progress Report(PPR) to be submitted in due course
- Schemes or any part (s) thereof should not be taken up/proposed to be taken up under any other schemes like State Plan, NLCPR, SCA, CM's Special Package, ACA, FMP, NABARD, MPLAD, MLALAD etc. and any other schemes taken up by the department.
