Secretary, NEC, in exercise of the financial power authorized by Govt. of India, Ministry of DONER vide letter F.No. 4/1/2010-DONER (NEC) dated 7th September, 2012 hereby accorded sanction for release of Rs. 287.28 lakhs (Rupees Two Hundred Eighty Seven Lakhs and Twenty Eight Thousand only) to the State Government of Assam being 1st installment of grants under North Eastern Council for the purpose of "Construction of Regional Multi-Utility Town Hall & Cultural Centre in Tinsukia, Assam, under the scheme 'Preservation/Promotion of Art & Culture in the NER' during the year 2013-14 approved vide order No. NEC/IPR/362/2013 dated 28th February, 2014.

2. The grant is towards plan expenditure and should be utilized on the programme as per approved guidelines of North Eastern Council and no deviation from the provisions of guidelines is permissible.
3. The State Government should release its share immediately on the receipt of this Central share for this programme as per guidelines of this scheme.
4. The State Government will furnish the certificate of actual utilization of this grant within twelve months of the closure of accounts. In respect of expenditure by the State Government through local bodies or private institutes, the utilization certificate is required to be furnished by the State Government.
5. The entire assistance in the form of grant is "Provisional" and is subject to adjustment on the basis of audited figures of expenditure of the North Eastern Council Plan Scheme for 2013-14.
