

Minutes of the 2nd Meeting of State Level Sanctioning and Monitoring Committee(SLSMC) under Pradhan Mantri Awas Yojana(PMAY) on 26th September, 2016 at 12.00 Noon at the Conference Hall of Chief Secretary, Assam Secretariat, Dispur, Guwahati -06

The meeting was chaired by the Chief Secretary, Assam. The chairman welcomed all the members present and took up the agenda of the meeting for discussion.

The Mission Director gave a power point presentation on the Detail project Reports of 8 Towns, Capacity Building Plan on constitution of State Level Technical Cell (SLTC) and City level technical Cell (CLTC), Model Building Plan that had already been examined and appraised by the State level Appraisal Committee (SLAC) for taking forward the Prime Ministers Awas Yojana (Urban) Mission.

Additional Chief Secretary to the Government of Assam, Urban Development Department appraised the Chief Secretary about the action take so far on various component of PMAY.

The members deliberated on the following issues-

- 1. 8 (eight) towns, i.e. Tinsukia, Dibrugarh, Jorhat, Nagaon, Silchar, Guwahati, Dhubri and Kokrajhar have submitted DPRs on Beneficiary Led Construction (BLC) component of Prime Ministers Awas Yojana (PMAY).
- 2. It is noted that ULBs have submitted the DPR as phase-1 and will submit DPRs in phases depending on progress of field verification as field verification of status of house/units takes time. The Committee unanimously approved the DPRs of 8(eight) Towns with the following details.

3. Chief Secretary to the Government of Assam suggested to submit the DPRs to Government of India with approval of Hon'ble Minister. Urban Development Department. Assam.

- 4. The Committee decided that Demand Survey shall be carried out by Consultants as prescribed by Central Sanctioning and Monitoring Committee (CSMC). Chief Secretary to the Government of Assam also suggested to explore possibility of selection of consultants from list of empanelled Consultants of Government of India, if available.
- 5. The model Dwelling Unit for construction under BLC component is approved for Rs. 2, 99,200.00 as cost per unit of construction of dwelling unit. Out of 2, 99,200.00 the Central Assistance will be Rs.1,50,000.00, the State will support with Rs. 50,000.00 and beneficiary contribution will be Rs. 99,200.00.
- 6. The committee approved the proposal for constitution of State Level Technical Cell (SLTC) and City level technical Cell (CLTC).
- 7. The Committee discussed about the selection procedure of SLTC which was initiated last year and decided to cancel the selection process because of the following reasons:
 - I. Before constitution of SLTC and CLTC approval of Ministry of Urban Development, Government of India is necessary, SLTC personnels were selected without its approval.
- II. Though initial selection was done, no appointment letters were issued. Since the selection process was initiated last year, it is proposed to cancel and initiate it afresh so that a wider choice of professionals is available.
- III. Starting selection process without approval of Government of India may lead to avoidable complications of reimbursement of expenditure.
- IV. Therefore a fresh selection process may be initiated after taking due approval from the Government of India.
- 8. The meeting ended with vote of thanks from the Chair.
