NOTIFICATION

Dated, Dispur the 30th September, 2019

No. UDD(M)89/2012/133 : It is hereby notified for general information that the Governor of Assam in exercise of the powers conferred under Section 4 (1) (a) of the Assam Municipal Act, 1956 (Assam Act No. XV of 1957) as amended intends to constitute Sipajhar Municipal Board with 8 (eight) Wards as shown in the Schedule below in the District of Darrang for providing improved amenities within the limits of the boundaries upon which municipal fund may be expended with respect to all matters mentioned under Section 60 of the Assam Municipal Act, 1956 as amended and further to categorize the Municipal Board as Municipal Board Category IV (MB-IV) on the basis of population therein under Section 4 (1) (e) of the Assam Municipal (Amendment) Act, 2017.

Any objection to the proposal or anything contained in this Notification for consideration may be submitted to the State Government through the Deputy Commissioner, Darrang in writing within the period of 42 (forty-two) days from the date of publication of this Notification in Assam Gazette.


